 - mechanical ventilation

 - bilevel positive airway pressure (BiPAP) machine
 - continuous positive airway pressure (CPAP) machine
- H-2-3 Demonstrate knowledge and ability to care for client with oxygen therapy devices including:**
- laryngeal mask airway (LMA)
 - nasopharyngeal airway (NPA)
- H-2-4 Demonstrate knowledge of safety precautions when utilizing oxygen therapy.**

 - appropriate suction pressure

- assisted coughing
 - deep breathing and coughing
 - incentive spirometer
 - orthopneic position
 - percussion (clapping)
 - postural drainage
 - vibration
- H-4-3 Demonstrate knowledge and ability to evaluate effects of respiratory interventions.**

Tracheostomy Care

Date: January 16, 2017

A Licensed Practical Nurse will:

- H-5-1 Demonstrate knowledge and ability to recognize indications and contraindications associated with tracheostomy tubes.**
- H-5-2 Demonstrate knowledge and ability to manage tracheostomy care:**
- administering nebulized medication into a tracheostomy
 - changing tracheostomy dressing
 - changing and/or cleaning an inner cannula of a tracheostomy tube
 - changing of tracheostomy ties
 - cleaning a tracheostomy tube
 - changing established tracheostomy
 - deflating/inflating a tracheostomy cuff
 - humidification
 - capping a tracheostomy tube
 - suctioning
 - using manual resuscitator (Ambu bag)
- H-5-3 Demonstrate knowledge of indications and contraindications of mechanical ventilation.**
- H-5-4 Demonstrate knowledge and ability to manage a client with mechanical ventilation.**

Chest Tubes

A Licensed Practical Nurse will:

- H-6-1 Demonstrate knowledge and ability to apply critical thinking and critical inquiry throughout the nursing process in care for client with chest drainage system.**
- H-6-2 Demonstrate knowledge and ability to recognize indications and contraindications for chest tube insertion such as:**
- hemothorax
 - pleural effusion
 - pneumothorax
 - surgical treatment
 - tension pneumothorax
- H-6-3 Demonstrate knowledge and ability to assist with insertion/removal of pleural chest tube.**
- H-6-4 Demonstrate knowledge and ability to maintain an established chest drainage system.**
- H-6-5 Demonstrate knowledge and ability to manage chest tube dressing changes.**
- H-6-6 Demonstrate knowledge and ability to identify complications and appropriate interventions for client with chest drainage system including:**
- absence of fluid fluctuation in water seal chamber
 - apparatus lifted to client's chest
 - apparatus malfunction
 - chest tubes dislodged
 - continuous bubbling in the water seal chamber
 - hemorrhage
 - incorrect tube placement
 - monitor drainage (amount/colour)
 - pulmonary edema
 - signs of infection
 - subcutaneous emphysema
 - tube occlusion
