CANADIAN OLYMPIC GOLD MEDALIST, JOAN MCCUSKER, TO BE KEYNOTE SPEAKER AT SALPN 2010 EDUCATION CONFERENCE AND AGM

The Saskatchewan Association of Licensed Practical Nurses is pleased to announce that the Keynote Speaker for their 2010 Education Conference and AGM will be Joan McCusker, Canadian Olympic Gold Medalist, Broadcaster and Motivational Speaker.

Joan McCusker believes it is ordinary people who do extraordinary things. Through her experiences as a teacher, mom, world champion curler, Olympic Gold Medalist and CBC Commentator, Joan has collected a number of observations on the attitudes that propel ordinary people to build extraordinary lives. With a big smile, plenty of

humour and tons of Olympic examples, Joan explains the type of attitude and teamwork that builds success in every aspect of life.

Joan McCusker won numerous awards as a member of the Sandra Schmirler Curling Team, including three Canadian and World Women's Curling Championships (1993, 1994, and 1997) and an Olympic Gold medal at the 1998 Nagano Games. Joan and her six brothers and sisters grew up on the family farm around Saltcoats, Saskatchewan. She graduated from the University of Saskatchewan in 1987 with a Bachelor of Education. She was an elementary school teacher until 1998 when she decided to focus her time and energy on being a mom, a curler, a CBC Sports commentator, a high performance consultant and a motivational speaker.

Joan and her husband Brian live in Regina with their three children, Rory (17), Christina (13) and Shae (10). Joan's travels have shown her successful people in all walks of life. She sees the parallels between sports psychology and successful strategies used in business, community and family. Joan has plenty of examples of ordinary people doing extraordinary things.

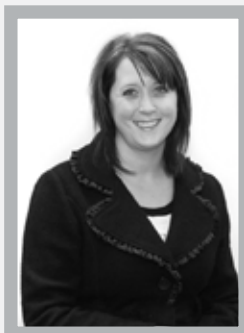

CALL FOR RESOLUTIONS

Saskatchewan Association of Licensed Practical Nurses Call for Resolution 2010 Annual General Meeting

1. Submission of Resolutions

The SALPN Executive Director must receive all resolutions for presentation at the Annual General Meeting before **February 22, 2010**. This allows sufficient time for review of the Resolutions and for publicizing them to chapters and individual members through the Annual Report.

2. Procedure at Annual Meeting

In compliance with the Licensed Practical Nurses Act, 2000, Section 28(1) the procedures at all meetings of the Association and of the Council shall be governed by the procedures contained in Appendix B and in most cases not provided for, by the Rules set out in Procedures for Meetings and Organizations, third edition, M. Kay Kerr and Hubert W. King, (Toronto, Canada: Carswell, 1996.)

Each resolution is read aloud from the Chair and the name of the member who submitted the resolution is stated. The Chair will then call for a mover and a seconder for the proposed resolution. The person moving the resolution will also be called upon to speak to it.

If you do not have an e-mail address on file with the SALPN Office, we will send you the same information by regular mail in early February so that you can go to the secure website and complete your survey.

The online survey will be available twenty four hours a day, seven days a week for the month of February. This will allow members to access and complete their survey at a time of their choosing. The survey results are being collected and will be reported on by a professional market research firm located here in Saskatchewan. We will report the results of the survey on the SALPN website as soon as they are available, likely by mid-March.
